PUBLIC HEARING – 7:55 P.M. – Conditional Use #05-0-21-CU – CL van Veen Construction Ltd, NE 24-13-19

The hearing was advertised and notices were placed as required.

In attendance: Brent Fortune, Chair; Walt Froese, Mark Gill, Ken Hyndman, Gavin Reynolds, Frank Hyndman, Robert Christie and Marci Quane, C.A.O.

Public in attendance: Cherry van Veen, Leo van Veen, Roy McTavish, Sandra McTavish, and Karen Greer

Chairperson Fortune opened the hearing. The C.A.O. advised that the purpose of the hearing was to receive public presentations from any person who wish to make them in respect to the Conditional Use Order.

Public Presentations: The following people presented information at the hearing:

- 1) Leo van Veen from CL van Veen Construction Ltd. informed the board that a Conditional Use Order was requested to establish an office and workshop for his business within the agricultural general zone. Developing along #10 Highway will provide for additional exposure for his company. He would build RTM's on location when his company is not busy fulfilling custom work contracts.
- 2) The CAO, Marci Quane, read aloud letters submitted by Roy and Sandra McTavish and Karen Greer in opposition of the conditional use.

Questions: Council clarified information regarding CL van Veens proposal relating to type of construction, how many employees would report to work at this location, if van Veen's have had current complaints regarding the construction at their present location and if the existing buildings and property would be removed. Roy McTavish expressed his concerns with the noise and how it would affect the habitat of the area as he had signed an agreement with the Manitoba Habitat Heritage Corporation, the safety concerns of traffic turning off #10 Highway, and that exposure of CL van Veen's business should not come at the new neighbor's expense. Karen Greer highlighted her concerns regarding safety, as accidents have happened in this area. Councillor Reynolds asked if those in opposition had mitigation or if they were opposed to the proposal entirely. Roy McTavish responded that he would be ok with the office being approved but not the construction.
