ARISING FROM THE MINUTES

1. Property Standards – Commissionaires have given ratepayers who are in contravention of the bylaw until the end of June to clean up properties. Any properties still in violation will be cleaned up by Commissionaires and costs for same will be charged back to the property in violation. It is hoped that ratepayers will clean up their properties before the June 30th, 2021 deadline so that Commissionaires will not have to complete the work.

NEW BUSINESS

- 1. Student Employment Grants were applied for and applications will be received as soon as possible.
- 2. Projects for 2021 An ICIP grant to place asphalt on certain streets in Oak River was applied for in 2019 and if it is approved, it is hoped that some paving will be completed in 2021. Areas where dust control should be applied were discussed.
- 3. Nuisance bird control Authorizing certain individuals to help control nuisance birds in Oak River was discussed.
- 4. Dissolution of the LUD of Oak River The size of the L.U.D. of Oak River and the mill rate for the LUD of Oak River was discussed. It was suggested that a comparison be done in regards to costs of taxes in Oak River if the LUD was dissolved and special service levies were placed on the properties. A power point presentation is to be worked on to present at future meetings.

SERVICE PLAN FOR 2021

The Finance Manager reviewed the draft financial plan with the LUD Committee members. The Finance Manager reviewed possible increases in taxes if the mill rate for the LUD of Oak River increases 1.52 mills with the members. Paving in Oak River will hopefully be completed this year. The finance manager inquired if the Committee could see where any changes should be made to the draft 2021 service plan.
