## THE RURAL MUNICIPALITY OF OAKVIEW

## BY-LAW NO. 2015-20

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF OAKVIEW IN THE PROVINCE OF MANITOBA, PROVIDING FOR THE JOINING OF AN ESTABLISHED MUNICIPAL LIBRARY IN ACCORDANCE WITH THE PROVISIONS OF "THE PUBLIC LIBRARIES ACT" BEING CHAPTER 220 OF THE REVISED STATUTES OF MANITOBA 1987.

WHEREAS the Council of the Rural Municipality of Oakview deem it desirable and in the best interests of the residents of the Rural Municipality of Oakview to become a supporting municipality to the Rapid City Municipal Library;

NOW THEREFORE BE IT and IT IS HEREBY ENACTED as a by-law of the Rural Municipality of Oakview that:

- 1. That the Reeve and Chief Administrative Officer of the Rural Municipality of Oakview shall on behalf of and in the name of the said Municipality negotiate and execute an agreement between the said municipality and the Rapid City Municipal Library Board, in accordance with the provisions of Section 29(4) of the "Public Libraries Act" aforementioned.
- 2. That the said agreement shall provide for the appointment of 4 (four) citizen representatives and 1(one) council representative to the Rapid City Municipal Library Board, And such other provisions as may be required by the "Public Libraries Act" or as may be deemed necessary or advisable and are not inconsistent with the said Act.
- 3. Rapid City Municipal Library shall, on or before the fifteenth day of January in each year, lay before the council of Oakview municipality a detailed estimate of the amount required by the Board to meet the expense of maintaining and operating the Library for the next ensuing calendar year.
- 4. The Regional Library Board shall have all the duties and powers set out in the provisions of Part III Section 27 of "The Public Libraries Act".
- 5. That By-Law No. 99-4 of the former R. M. of Blanshard; By-Law No. 3-74 of the former Town of Rapid City; and By-Law #793 of the former R. M. of Saskatchewan are hereby repealed.
