BY-LAW NO. 2016-6

Being a By-Law of the Rural Municipality of Oakview to amend R.M. of Blanshard's By-Law No. 2013-3

Being a By-Law to provide for the expenditure and borrowing of funds for the purchase of a new fire truck for the Rural Municipality of Blanshard

WHEREAS, the Rural Municipality of Blanshard, by its By-Law No. 2013-3, which was authorized by Municipal Board Order No. E-13-061, is inter alia, authorized to issue borrowing in the amount of \$135,000.00;

AND WHEREAS, no borrowing as authorized by said By-Law No. 2013/3 has been issued or sold;

AND WHEREAS, the Rural Municipality of Blanshard has amalgamated with the Rural Municipality of Saskatchewan and the Town of Rapid City effective January 1st, 2015 under Regulation 107/2014 to form the Municipality of Rural Municipality of Oakview;

AND WHEREAS, the Rural Municipality of Oakview has made arrangements to borrow from Vanguard Credit Union in the amount of \$100,000.00, being the costs of works completed under the authority of By-Law No. 2013-3, such borrowing to be dated 31st day of December, 2013, to bear interest at the rate of 3.1500 per annum, payable annually during their currency, and to mature on 31st day of December in each of the years 2014 to 2018;

AND WHEREAS, it is deemed expedient to amend said By-Law No. 2013-3 to provide for the issuance of the aforesaid borrowing;

NOW THEREFORE, the Council of the Rural Municipality of Oakview, in council duly assembled, hereby enacts as follows:

- 1. **THAT** By-Law No. 2013-3 of the Rural Municipality of Oakview **BE AND THE SAME IS HEREBY AMENDED** to provide that borrowing in the amount of \$100,000.00 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 31st day of December, 2013, to bear interest at the rate of 3.1500 per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2014 to 2018, both inclusive.
- 2. THAT the issue of said borrowing provides financing for all costs of works completed under authority of By-Law No. 2013-3, and the balance of \$35,000.00 of authorized borrowing which will not be required or used is hereby cancelled.
