Purpose:

The purpose of this policy is to provide that a fee be payable by residents and ratepayers of the RM directly benefiting from the application of Dust Control on roadways.

Statement:

The Rural Municipality will apply dust control to areas designated by Council or Public Works on an annual basis and as per the current year's budget. Any residents or property owners wishing to have dust control on the municipal road fronting their property will be required to apply for dust control through the RM at their own cost.

1. The RM will post a notice in the local paper, on Facebook and on the website accepting requests for dust control for the upcoming season.
2. The applicant will be responsible for payment of the dust control at each site. Applications and pre-payments are to be received by the RM office(s) no later than the date specified in the advertisement.
3. The RM accepts no responsibility for the effectiveness of the dust control.
4. The RM reserves the right to perform such maintenance procedures as it deems necessary on the treated portions of the roadway.
5. Although the RM will attempt to minimize any adverse effect of maintenance operations on the treated portion of the roadway, the RM will not accept liability for any restoration required.
6. This policy interprets "roadway" as only those roadways that are under the jurisdiction of the RM as outlined within The Municipal Act.
7. The RM reserves the right to apply dust control on any roadway. The application shall be at the discretion of the RM.
8. The RM has the right to refund all pre-payments in the event that there are not enough requests for a truck load.
9. The RM applies dust control on portions of the following roadways. This list is not inclusive and may be added to at the discretion of the RM.

- Oak River:
 - South Railway Street (in front of the Carwash)
 - South Railway Street (behind Senior's Home)
 - Miller Street ("lane" heading into rink)
- Rapid City:
 - Sample Ave West (1st Ave & around the campground)
 - 385 Seventh Ave (RC RM Shop)
- Riverdale Municipality:
 - Road 72N (SW 1-13-21W)
 - Road 72N (NW 32-12-21W)
 - Road 71N (SE 36-12-21W; Civic 120075) - RM pays 50%; cost shared
 - Road 120W (NE 25-12-20w)
- Provincial Dust Control (a provincial application is filled out):
 - PR 270 South (heading out/South of Rapid City)
 - PR 354 (SE 35-15-22W; in front of Stockpile)
