GENERAL BUSINESS

1. Assessment Services - Assessment Changes (taxes to be added and decreased for 2017) were reviewed with Council. Tax additions and deletions are to be calculated for the 2017 year.

2. Assistant C.A.O. position - the personnel committee recommended that no additional staff be hired at this time.
3. Rapid City Sewage lagoon - Memo #2 was received from SNC Lavalin Inc. outlining options available in regards to the environmental act proposal for the Rapid City sewage lagoon. A meeting was held between SNC Lavalin Inc.; MWSB; an Oakview Councillor and municipal staff to discuss the options available on August 31st, 2017. Information was received from Manitoba Infrastructure indicating that the property south of the existing lagoon is not available for sale at this time. The C.A.O. was instructed to investigate other options that may be available.
4. Civic addressing - Council reviewed signs to be ordered.
5. Drainage plan - Information received from G. Newton and Hamiota Municipality was reviewed with Council. The final report is to be received very shortly from the engineering firm.
6. Road reconstruction/repairs - work to be done on the Oak River culvert apron on Road 79 N was discussed.
7. Annual A.M.M. Conference in Brandon - early bird registration is due by October 19th, 2017. Noted.

8. Rapid City Rink - Invoices received from restoration companies were reviewed with our insurance adjuster and work is still to be completed before payment is to be made to the contractors. Quotes to replace equipment for the rink were reviewed.
