

# RURAL MUNICIPALITY OF OAKVIEW

## By- Law No. 2019-7

By-Law No. 2019-7 to amend By-law 7-2014 (Town of Rapid City By-Law to designate the buildings of the Rapid City Museum as Municipal Heritage Site).

Being a by-law of the Rural Municipality of Oakview de-designating the subdivided portions of the Block marked "Market" in the former Town of Rapid City, in Manitoba, which Block was shown on a Plan registered in the Neepawa Land Title Office as Plan "A". EXCEPTING THEREOUT: All Mines and Minerals as set forth in a Transfer registered in the Neepawa Land Titles Office, as No. 199861. This Parcel was subdivided in 2016 and Lot 4 Plan 59657 which houses the Museum Buildings is to stay a Municipal Heritage Site and Lots 1, 2 & 3 of Plan 59657 are to be de-designated.

WHEREAS Section 32 of the Heritage Resources Act states that "A municipality may, at any time, on its own motion and without a hearing, (b) where a by-law, as proposed or as amended, has received 2<sup>nd</sup> and 3<sup>rd</sup> reading and has been adopted under this Part, by a further by-law revoke that by-law"

AND WHEREAS Section 25 of The Heritage Resources Act Authorizes the Council of a Municipality to enact by-laws to designate a municipal site as a municipal heritage site.

AND WHEREAS the Council of the Rural Municipality of Oakview has cause to serve upon the Minister of Sport, Culture, and Heritage, c/o The Heritage Designation Office, Historic Resources Branch, Main Floor, 213 Notre Dame Avenue, Winnipeg, Manitoba R3B 1N3 subdivided lots of the Market Block

THEREFORE, BE IT RESOLVED that the Council of the Rural Municipality of Oakview enacts as follows:

1. The site commonly known as the Rapid City Museum with original legal description as described in C.T. #166955 as follows: The Block marked "Market" in the Town of Rapid City, in Manitoba, now with legal description of Lot 4 Plan 59657 Title #2851990, Roll #418600, Neepawa will hereby remain as a Designated Heritage Site.
2. The following parcels that were subdivided from the original "Market" block, hereby be de-designated as heritages sites pursuant to The Heritage Resources Act:

Lot 1 Plan 59657, Roll #418695, Title No. 2851987, Neepawa  
Lot 2 Plan 59657, Roll #418690, Title No. 2851988, Neepawa  
Lot 3 Plan 59657, Roll #418685, Title No. 2851989, Neepawa
