

THE RURAL MUNICIPALITY OF OAKVIEW

BY-LAW NO. 2020-1

A BY-LAW OF THE RURAL MUNICIPALITY OF OAKVIEW TO ESTABLISH A RATE FOR THE SPECIAL SERVICE LEVY FOR THE MAINTENANCE AND OPERATION OF THE AGRICULTURAL AND COMMUNITY DISTRICT (HALL) OF NEWDALE for the years 2020 to 2029.

WHEREAS Section 312 of "*The Municipal Act*" of Manitoba, provides in part as follows:

312 If approved by by-law, a municipality may provide, as a special service to all or part of a municipality, one of more of the following:

(g) recreation support services;

AND WHEREAS subsection 320(1) of the Act provides as follows:

320(1) Subject to subsections (2) to (6) and subsection 321(4), a council may by by-law

- (a) approve the local improvement or special services as set out in the plan or proposal; and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

AND WHEREAS, *The Agricultural and Community District of Newdale Act* established the Agricultural and Community District of Newdale corporation, the lands that comprise the district, and that a board of trustees have the authority to raise a reasonable amount for the maintenance expenditures of the district, by an annual levy on all the taxable land of each municipality situated in the district;

AND WHEREAS the Council of the Rural Municipality of Oakview has prepared Special Services Plan No. 2020-1 to establish a rate for the maintenance and operation of The Agricultural and Community District (Hall) of Newdale as a special service pursuant to Part 10 of *The Municipal Act*;

AND WHEREAS the requirements as prescribed in section 318, 319, and 320 of the Act have been complied with;

NOW THEREFORE the Council of the Rural Municipality of Oakview, in open council assembled enacts as follows:

1. That pursuant to subsection 320(1) of the Act, Rural Municipality of Oakview approves Special Service Plan No. 2020-1 attached hereto as Schedule "A".
2. That the Rural Municipality of Oakview levy a special service tax annually upon all taxable land situated within the Agricultural and Community District of Newdale in the municipality as hereby attached in Schedule "B".
